Course Description:

This course offers an introduction to the financing and organization of the U.S. health care system and the public policies and laws that impact that system. Topics covered include health care cost and access; federal and state regulation of private health insurance and managed care; financing of public health programs, including Medicare and Medicaid; the structure of the health care enterprise; and legal issues related to the organization and reform of the delivery of health care, including anti-trust and fraud and abuse.

Course Requirements:

With the implementation of the Patient Protection and Affordable Care Act of 2010 (upheld by the Supreme Court in 2012), the landscape of health law and policy is going through fundamental changes. The most important requirement for this course is to be actively engaged and interested in learning the basics of health care organization and finance and be prepared to learn together as the landscape shifts in front of us.

Each student will be required to write a weekly reflection paper and will be required to complete a final take home examination.

First Week Submission: For the first class, please submit several paragraphs explaining your goals for the class, interest in health law and policy, any prior work or academic experience in the subject, and any career plans/ambitions in the field of health law and policy. - Weekly Reflection Papers: Each week, you will be required to submit a short reflection paper prior to class. The weekly reflection papers should be no longer than one page. You may either comment generally on your reactions to the readings, or you may raise several questions about the readings that you would like discussed in the class session. They are <u>due at 9:00 p.m. on Wednesdays</u> of each week and must be <u>emailed to me at ann.oleary@tcng.org</u> by that deadline. During the course of the semester you have *three free passes* to use in which you may email me by the allotted time to let me know that you will be using one of your free passes that week.
- *Final Exam:* The grade for this course primarily will be based on the final exam. The final exam is a 24-hour take home examination that you will be able to take any time during the law school's examination period: April 29 to May 9, 2013. The weekly reflection papers and class participation will be used as a plus factor in determining final grades.
