Payment

Pre-payment is required for all orders. We accept U.S. bank checks or Visa and Mastercard. Please do not email us your account number: we are prohibited by the University of California from storing it in any electronic form. Shipping

We ship all domestic orders UPS ground: \$6 for the first book + \$2 for each additional book. For corporate accounts, we are happy to drop ship. Include an email address in your order to receive automatic tracking information from UPS.
