Produced Water Solutions Inc is subject to the Colorado Discharge Permit System, Permit No. COG840001 (Permit). The Permit authorizes Produced Water Solutions Inc to discharge treated wastewater subject to the specific effluent limitations and other conditions of the Permit. 5 CCR 1002-61, §61.8, requires a permittee to comply with all the terms and conditions of the permit.
