Andrew,

Thanks for discussing this permit with me last week. Sorry it has taken a bit for me to get back to you. As we discussed, we would like to modify our discharge permit based on the following:

- We are permitted to receive 7,500 barrels of produced water a day; the air permit is based on discharge and is currently being modified to accommodate this number.
- We would like for our discharge permit to be based on a worst-case scenario where we process 100% of the
 water we receive, and a best case scenario where we are able to achieve 85% permeate through our reverse
 osmosis system. Therefore, we are requesting to discharge 6,375 barrels (267,750 gallons) per day.
- Due to the higher volume, discharge will be semi-continuous rather than intermittent.
- We understand that this higher discharge volume will affect the requirements for discharge water quality.

Please let me know if you have any questions or would like any further clarification.
