I would like to follow up on the progress of the new permit for the Anderson #1 site in Washington County operated by Ritchie Exploration, Inc.

Some time ago, I discussed with you the permit for this site issued on March 13, 2012, Permit Number COG 8400000, Certification Number COG840011. As you may recall, this permit was written incorrectly and describes the site as being in Garfield County and discharging to an intermittent stream tributary to the Colorado River. The new permit specified increased sampling for this site based on stream standards formulated for tributaries to the Colorado River, when in fact the discharge is not tributary to any receiving stream. Under the old general permit, Ritchie was only required to sample TSS, pH, and oil & grease.

At that time you instructed me to have Ritchie submit another permit application, which was sent to you in January. I was just informed by Ritchie that someone from the Division called and stated they are out of compliance with the permit written last year. Can you check on the progress of the new permit application? If necessary, I can come to your office to discuss this matter with you.

The existing permit also names the Colorado River and the South Platte River in other spots. No, the discharge is to an unnamed drainage that is not tributary to any receiving stream. There is an area in central Washington County where the drainage flows to the northeast but ends before discharging to any named stream.

Hi Dave.

I do see that the letter associated with your permit certification does contain an error in reference to the Colorado River. However, the permit certification itself (which is the document Ritchie would need to be in compliance with) is based upon the water quality standards associated with a drainage in the Republican River Sub-basin, segment COSPRE06, not the Colorado The reference to the Colorado was a typo only in the letter, not the permit.

The permit is appropriatedly written for segment COSPRE06, an 'all tributaries' segment. Discharges to drainages, even if ephemeral, require the application of permit limitations associated with the applicable watershed, in this case the Republican River. I have attached a link to Regulation No. 38 which describes segment 06 of the Republican.
