- Your personal statement that describes any business, professional, community or school activities in which you have been involved; outlines your qualifications; describes your connection to Kern County, California; sets forth your short term and long term goals upon successful completion of law school and the bar exam; and, identifies and discusses your views on a major issue confronting American society or American women.
