Anita Krug, BCLBE Research Fellow, has accepted a position as an Assistant Professor of Law at the University of Washington School of Law. Anita will relocate to Seattle this summer. This Spring she will teach her course on **Hedge Funds and Investment Management Law** at Berkeley Law and continue to research and write on hedge fund regulation and systemic risk issues at BCLBE.

BCLBE is offering two student fellowship programs during the coming year. Through funding from the UC Berkeley Stem Cell Center, BCLBE will award two \$10,000 full year **Stem Cell Research Fellowships**. The fellows will participate in BCLBE Innovation and Entrepreneurship research projects that address stem cell intellectual property commercialization, and pursue an independent project that investigates legal and economic issues arising in the research, development and commercialization of human stem cell technology. The second fellowship program, part of the BCLBE China Program, will support student travel and living expenses for a summer internship at the **Beijing Arbitration Commission** (BAC). Applications for the fellowships are due January 11, 2010.
