- 1. Read these instructions, then fill out the reverse side.
- 2. JD students from Golden Gate, Hastings, Univ. of San Francisco and Univ. of Santa Clara may take a law course at Boalt Hall if the course: (please note UC Davis & Stanford students should also apply through the Exchange Program specific to their school)
 - * is not oversubscribed:
 - * is related to your course of study and/or career goals;
 - * is not offered at your home school in a given academic year;
 - * is approved by your home school, the course instructor, and the Boalt Hall Dean of Students. You may not take more than eight total units at Boalt Hall within three years.
- 3. The Boalt calendar does not always match that of the main campus, nor your home school. You are responsible for knowing Boalt dates and deadlines.
- 4. Check with your home Registrar to insure that you may take a course at Boalt and to clarify how the units will be treated.
- 5. Obtain the signature approval of your department head or Registrar.
- 6. At the first class meeting, inform the instructor that you wish to take the class and obtain his/her signature approval.
- 7. Bring this form with faculty signature to the Registrar's Office, 270 Simon Hall.
- 8. You will be notified by the Registrar's Office via email if your application has been approved. Please note we will not review applications until two weeks after classes begin.
- 9. You must take the course for the grade option <u>selected by the law school</u> either for CR/NC or a grade. Most courses at the law school are offered for a grade. Refer to the Boalt schedule of courses for exceptions to the standard Boalt grading option. Your home school may interpret Boalt grades on your transcript. Check with your home Registrar to determine how your Boalt grade will appear.
- 10. You will need an exam number to take Boalt Hall exams. You may obtain your exam number here: http://www.law.berkeley.edu/php-programs/students/exams/index.php
- 11. You must take the final exam on the published date, time and place NO re-scheduled exams will be allowed.
- 12. We will mail a transcript directly to your home school after grades are posted. This will be at least six weeks after exams end. If you need Spring Semester grades for graduation or Bar certification purposes, note the deadline date on the reverse side. We will try to send pass notification to your school by the deadline you request. ** We can not release grades until after the exam period has ended and faculty have had a chance to review the finals.
