

Jameel Jaffer is a litigator for the American Civil Liberties Union (ACLU) and Director of the ACLU's National Security Project. Jaffer is a graduate of Williams College, Cambridge University, and Harvard Law School. Currently, his docket includes *Doe v. Gonzales*, a challenge to the FBI's "national security letter" authority, and *ACLU v. Department of Defense*, litigation under the Freedom of Information Act for records concerning the treatment and detention of prisoners held by the U.S. in Afghanistan, Iraq, and at Guantánamo Bay.

Bill Roller is president of the Berkeley Group Education Foundation, a nonprofit which produces symposia on ethics and human rights. He chairs the Ethics Committee of the International Association for Group Psychotherapy and Group Processes and is a principal in the consulting firm Consultants for the New Global Environment, which promotes energy efficiency by business and government. A family and group therapist, he practices in Berkeley.

Jean Maria Arrigo, Ph.D., an independent social psychologist and oral historian: founder of the *Intelligence Ethics Collection* at Hoover Institution Archives, and the Project on Ethics and Art in Testimony (www.peat-intel.org); member of the 2005 APA commission on psychologist-assisted interrogation; recipient of the 2009 Southwest Oral History Association Mink Award and the 2009 Marsella Prize for the Psychology of Peace and Social Justice.

Robert Cole graduated magna cum laude and Phi Beta Kappa from Harvard in 1952, and received his LL.B., magna cum laude, in 1955 from Harvard Law School. He clerked for Justice Sherman Minton of the U.S. Supreme Court and then worked in Washington, D.C., in the Office of the Secretary of the Air Force. He has taught constitutional law, torts, jurisprudence and legal ethics at Berkeley Law and has been a visiting law professor at Northwestern, Harvard, and Banaras Hindu University in India.

Danner is a journalism professor at the University of California, Berkeley. Among his books are *Stripping Bare the Body: Politics Violence War and Torture and Truth*.
