Assistant Clinical Professor of Law & Director, Environmental Law Clinic (July 2015 – Present) Established, and presently direct, the Environmental Law Clinic. Supervise students in administrative advocacy, litigation, legislative, and policy projects related to environmental health and environmental justice. Teach companion lawyering skills seminar, and supervise Clinic staff. Mentor undergraduate auditors through Clinic-created program to increase diversity in the environmental legal field. Produce academic scholarship and serve on school committees. Guest lecture in other law school classes and campus departments; present at professional conferences on varied environmental topics; argue court cases; testify before legislative bodies; and work with media and documentary filmmakers to raise profile of environmental issues.

Clinic victories include: successful litigation against U.S. Environmental Protection Agency to force improved planning for offshore oil spills, and against California Department of Public Health to force release of a guidance document on reducing personal exposure to cell phone radiation; legislative drafting and technical research for client S.F. Department of the Environment to support its enactment of a first-in-the-nation ordinance restricting toxic chemicals in compost; legal advice to Breast Cancer Prevention Partners that enabled introduction of a California Senate bill to force disclosure of toxic ingredients in cosmetics and personal care products; and successful administrative advocacy at the California Public Utilities Commission to direct millions of dollars to affordable clean-energy projects in disadvantaged San Joaquin Valley communities, and better serve such communities during power shutoffs.
