No. S-91-1462), 30 F.3d 1107 (9th Cir. 1994): With Charles Wheeler and Bruce Goldstein, one of principal counsel in suit attacking retroactivity and notice and comment deficiencies in INS regulation affecting SAW applicants; drafted some of the motion papers in district court and 9th Circuit and argued motions for summary judgment/ opposition to judg't on the pleadings and motion for supplemental relief; assisted in editing appellate briefs and argued appeal in Ninth Circuit.

Espindola v. INS (E.D. Schl. Dist. of Valley Grove v. Girty 60 Fed. Appx. 889 (3d Cir.), 175 Ed. Law Rep. 408, 2002 WL 31477721: Contributing author (with Judith Gran) to amicus curiae brief on behalf of disability rights organizations urging affirmance of district court holding that under federal disability law, a secondary school student with mental retardation can benefit from general education classroom instruction and must have appropriate supplementary aids and services.

Tri-County Special Educ. Local Plan Area v. County of Tuolumne 123
Cal.App.4th 563 (2004): Principal author of *amicus* brief, with Dale Mentink and William Koski, on behalf of United Advocates for Children of California, urging that students with disabilities continue to receive mental health services notwithstanding County's allegation that state mandate to provide services is insufficiently funded.

<u>Central Valley Equal Rights Council v. American Friends Service Committee, et al. v. United States, (Case No. 11.072), Inter-American Commission on Human Rights: With P. Schey, Paul Hoffman, L. Guttentag, R.S. Abascal and Ira Gollobin, submitted complaint against U.S. for violations of regional human rights accords, including rights to life, equality before the law, judicial protection and humane treatment following death or serious injury to immigrants perpetrated by INS Border Patrol agents. Assisted in reply to Government's opposition.
