Course Materials: Richard Marcus, Edward Sherman and Howard Erichson, Complex Litigation (West 5th ed. 2010) ("MSE"). You will also need to have and bring to class every day an up to date version of the Federal Rules of Civil Procedure relevant to the day's discussion—any current version will do, including one downloaded from the internet. There will also be electronic handouts, probably on a pretty regular basis.

There are occasional assignments below from the Federal Judicial Manual on Complex Litigation (available on line at fjc.org).

There are also, less frequently, assignments from the American Law Institute's Principles of Aggregate Litigation. Those excerpts will be posted on bSpace.

Course Requirements: I will often lecture, but I will also often want to hear from you. Volunteers are always welcome. There will be a final examination in the course—it will be an 8-10 hour take-home with a strict word limit (currently 2500 words).
