# **International Business Transactions**

Course Description: This course provides an examination of the contractual and regulatory issues that arise when business dealings cross borders. It is structured in two parts. Part I covers the legal environment of international business, including the place of international law in the US legal system, the extraterritorial application of domestic law, and dispute resolution. Part II then builds upon this framework to explore eight representative transactions that lawyers advising businesses are likely to encounter: (i) export sales, (ii) agency and distributorship agreements, (iii) licensing, (iv) foreign direct investment, (v) mergers and acquisitions, (vi) joint ventures, (vii) development (concession) agreements, and (viii) international debt instruments. US, foreign, and international legal rules will be explored throughout the course.

<u>Required Materials</u>: The book for this class is Vagts, Dodge, Koh & Buxbaum, Transnational Business Problems (5th ed. 2014). Because the firth edition will not be published until early June, excerpts from the page proofs will be posted on bSpace. The page numbers in the reading assignments below refer to these page proofs.

<u>Class Meetings</u>: This class will meet during Quarter Two, June 4-19, from 9:00 am to 12:15 pm, with two ten-minute breaks. There will be no class on Friday, June 20. During each class session, I will call on students and ask them to respond to questions. We will take every opportunity to engage in class discussion. This is an important part of the learning process, and it requires that you prepare for class each day by reading the assigned materials.

<u>Examination</u>: The exam is scheduled for June 23. It will be approximately three hours in length and will include both multiple-choice and essay questions. During the exam, you may consult your course materials, notes, and any outline you have prepared yourself or in collaboration with others.
