Patents in Europe

National Patents

- Applied for nationally and granted nationally
- Enforced nationally

European Patents

- Applied for centrally at EPO but granted nationally
- Enforced nationally

Substantive law is the same (EPC 1973) but some differences (e.g. prosecution history estoppel) and big differences in litigation process

Currently still **no Unitary Patent** (or Unified Patents Court, **UPC**) – contrast with EUTMs and designs
