Director of Judicial Clerkships Position

After a rigorous national search, we expect to have a new Director of Judicial Clerkships on board this spring. As soon as it becomes official, we will be sending out a public announcement to the Berkeley Law community.

Clerkship Counseling Appointments in January 2021

In the meantime, I am hard at work making sure that the CDO is ready to support 2Ls in the upcoming clerkship application cycle.

If you have received any or all of your 2L fall grades, please feel free to share them with me as it will help me to advise you more effectively on strategy and targeting.
