Mr. Pollack:

I was hoping you could give me a quick call in an effort to save us and the Judge some time and effort.

I have now noticed that an amended complaint is on file in the above case, and can assume from the below entry that you now see that we did not get served (as I had not yet entered my appearance in the case). I don't see any good in answering the original complaint now that there is an amendment, but at least one new component is involved in the Amended Complaint and I would need more time to answer it.

Rather than file a motion with the Judge, I was wondering if you could agree to serve me by email with the Summonses and Amended Complaint today (or early tomorrow, if necessary). Then you can let the Court know that service been effected and I will have the 14 additional days for an answer under FRCP 15.
