NACDL v. Federal Bureau of Prisons and Department of Justice, Case No. 18-cv-02399 (D.D.C.) (KBJ).

Dear Ms. Graham:

This is the first interim response to your Freedom of Information Act request dated August 2, 2018, for records concerning federal prosecutor's access to emails between individuals held at Bureau of Prisons (BOP) facilities and their legal counsel. You request is currently in litigation NACDL v. Federal Bureau of Prisons and Department of Justice. Case No. 18-cv-02399 (D.D.C.) (KBJ). You should refer to this number in any future correspondence with this Office.

Please be advised that a search has been conducted in the appropriate sections and we are continuing to review and process the potentially responsive records. Thus far, we have identified 647 pages that are responsive to your request.

After carefully reviewing the records responsive to your request, I have determined that 113 pages are non-responsive, 400 pages are duplicates, two pages are appropriate for release in full, three pages are appropriate for release in part, and fifty-six pages are exempt from disclosure pursuant to:

5 U.S.C. § 552(b) (5), which concerns certain inter- and intra-agency communications protected by the deliberative process privilege and the attorney work-product privilege;

5 U.S.C. § 552(b) (6), which concerns material the release of which would constitute a clearly unwarranted invasion of the personal privacy of third parties; and

5 U.S.C. § 552(b) (7) (C), which concerns records or information compiled for law enforcement purposes the release of which could reasonably be expected to constitute an unwarranted invasion of the personal privacy of third parties.

Additionally, fifty-five pages originated with the Executive Office for United States Attorney's and eighteen pages originated with the Federal Bureau of Prisons. In accordance with

28 C.F.R. § 16.4(d) (2018), this Office referred that material to the appropriate offices for processing and direct response to you. If you have questions regarding these referrals, you may contact those agencies at the following addresses:

Your appeal must be postmarked or electronically transmitted within 90 days of the date of my response to your request. If you

submit your appeal by mail, both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."
