Since 2007, the Honorable G. William and Ariadna Miller Institute for Global Challenges and the Law has been the heart of Berkeley Law's international enterprise. Founded and supported by the generosity of G. William and Ariadna Miller, the Institute is a research, teaching, and policy center on international and comparative law.

Through interdisciplinary collaborations and institutional partnerships, the Miller Institute addresses urgent challenges that demand creative global approaches, including promoting the rule of law, climate and energy justice, anti-corruption, and human rights. Our work is guided by Berkeley Law's distinguished international and comparative law faculty and informed by the expertise of scholars and practitioners worldwide. The approach is collaborative, interdisciplinary, and strategic. Our initiatives and advocacy work target critical situations where we are uniquely equipped to promote lasting change.

The Miller Institute is named as a tribute to the Honorable G. William Miller ('52) and his wife Ariadna Miller.

A celebrated Berkeley Law alumnus, G. William Miller served as the US Secretary of the Treasury under President Carter and the 11th Chairman of the Federal Reserve. He was an officer in the US Coast Guard, and led a distinguished career in business and investment banking.

Miller was a lifelong supporter of Berkeley Law, serving on the school's Campaign Cabinet. As national chairman of the Distinguished Professors Project in 1986, he helped raise \$1.2 million to endow chairs honoring Berkeley Law professors. Miller was also the 1979 recipient of the Citation Award, the Berkeley Law Alumni Association's highest honor, and was recognized with the UC Berkeley Foundation Trustee's Citation in 1987.

He was deeply committed to enabling work to promote the rule of law as a means to ensure that nations share a set of values without sacrificing their individual cultures. The Miller Institute seeks to further his vision.

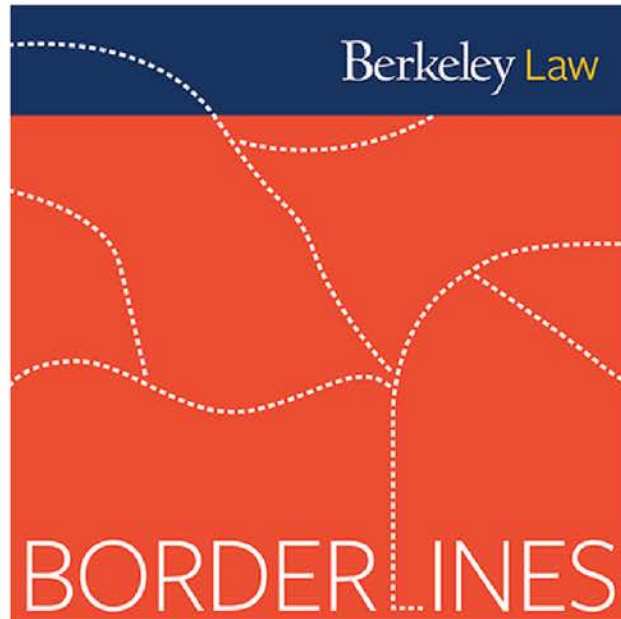

When the U.S. withdrawal from Afghanistan in August 2021 created a humanitarian crisis, an emergency response effort housed at the Miller Institute immediately sprang up to provide pro bono legal support to individuals at risk of persecution. Project Co-Directors and Berkeley Law alumnae Roya Massoumi '04 and Zulaikha Aziz '08 collaborated with Professor Laurel E. Fletcher, spearheading the training of more than 100 hundred students in fall 2021 to prepare visa applications for over 100 individuals fleeing Afghanistan and seeking refuge in the United States. The Miller Institute was proud to assist in this crucial effort.

STEFAN A. RIESENFELD AWARD AND SYMPOSIUM

BIG MONEY, BIG ENFORCEMENT: NEW FRONTIERS IN GLOBAL ANTITRUST REGULATION

International antitrust law addresses dynamic markets, competition, and regulatory responses. This hybrid day-long event brought together diverse global perspectives to present and discuss international antitrust's greatest challenges.

2022 STEFAN A. RIESENFELD AWARD

The Riesenfeld Award is given to a distinguished scholar or practitioner who has made outstanding contributions to the field of international law and who has demonstrated a commitment to the values that Professor Riesenfeld espoused. The 2022 Award was given to Margrethe Vestager, European Commissioner for Competition and Executive Vice President of the European Commission for a Europe Fit for the Digital Age. Commissioner Vestager is in charge of regulating commercial activity and enforcing the EU's rules designed to keep the markets fair. Commissioner Vestager has gained international recognition for her action against major multinational companies including American technology firms, among many others. Described by the New York Times as "perhaps the world's most famous [...] regulator," her work has redefined the field of antitrust regulation around the world.

STEFAN A. RIESENFELD
(1908-1999)

Stefan Riesenfeld ('37) was a Berkeley Law professor and recognized authority in numerous legal specialties including international law, comparative law, property law, creditors' remedies and bankruptcy, administrative law, and legal history. A native of Germany, he came to Berkeley in 1935 to earn a law degree. Speaking German, French, and Italian and with two European law degrees to his credit, he learned English only while studying at Berkeley. Nonetheless, he graduated on time and near the top of his class, and went on to receive a doctorate in law at Harvard. Professor Riesenfeld joined the Berkeley faculty in 1952 after teaching at Harvard and the University of Minnesota.

He served as a legal advisor in the Panama Canal treaty negotiations, the recognition of Taiwan, and the Iran hostage case. While in his 70s, he represented the United States in three major cases before the International Court of Justice. As civilian legal advisor with the US Office of the High Commissioner in the mid-1940s, he helped prepare the West German constitution.

He also wrote the statute for Hawaii's workers' compensation regulations and helped develop human rights litigation in the United States. Each year, the Miller Institute supports a symposium and an award in Professor Riesenfeld's name to keep alive his commitment to rigorous scholarship in international law and his devotion to public service.

Berkeley Journal of International Law (BJIL)

Infuses international legal scholarship and practice with new ideas; at the center of Berkeley's international law community, BJIL hosts professional and social events which engage likeminded students, academics, and practitioners in pressing international legal issues.

International Human Rights Workshop (IHRW)

Through careful legal research, detailed data collection, and comprehensive analysis, IRAP is dedicated to working alongside international courts and organizations to protect and promote human rights around the globe.

International Refugee Assistance Project (IRAP)

Organizes law students and lawyers to develop and enforce a set of legal and human rights for refugees and displaced persons. Mobilizing direct legal aid, litigation, and systemic advocacy, IRAP serves the world's most persecuted individuals and empowers the next generation of human rights leaders.

California Asylum Representation Clinic (CARC)

Primary mission is helping to guide and represent asylum seekers. CARC's secondary goal is to train Berkeley Law students in critical lawyering skills including interviewing, client management, and immigration law.

Journal of Middle Eastern & Islamic Law (JMEIL)

Provides a forum for the discussion of legal and philosophical issues relating to the Middle East and Islamic world. JMEIL publishes timely and original scholarship on the Middle East, Islamic law, and related topics.

Arts and Innovation Representation Project (AIR)

AIR's mission is to connect the worlds of law and art by supporting artists locally and around the world. By informing artists about their legal rights and safeguarding legal protections for artistic speech, students can help to empower the artistic community, which is often found at the helm of social change.

SALZBURG CUTLER FELLOWS

The Salzburg Lloyd N. Cutler Fellows Program brings together the nation's top law students with leading academics, judges, and practitioners in the fields of private and public international law.
