

## Certificate of Specialization in Environmental Law (JD)

### REQUIREMENTS FOR THE 2023-2024 ACADEMIC YEAR

The Certificate recognizes that students have gained both broad and deep experience in environmental, land use, and natural resources law. It may give students an advantage in obtaining jobs in those fields.

#### REQUIREMENTS

1. Environmental Law & Policy (LAW 271), Administrative Law (LAW 223), and Property Law (LAW 203);
2. A minimum of nine units of other courses in the Environmental Law category;\*
3. One additional course in the Public Law category; and
4. A substantial paper focusing on some aspect of environmental, land use, or natural resource law.

No course may count more than once. Courses that are used to satisfy the environmental law course requirements may not also be used to satisfy the public law course requirement, and vice versa. Any other exceptions or waivers to these requirements are made at the discretion of the faculty.

*\*Ecology Law Quarterly can satisfy up to two credits toward this requirement. The Pace University Environmental Law Moot Court Competition can satisfy up to one credit. Environmental clinics, field placements, practice projects and associated seminars may satisfy up to four credits total.*

#### ABOUT THE RESEARCH PAPER

The paper requirement can be fulfilled by completing the Environmental Law Writing seminar, the Environmental Law Clinic, an independent study (Law 299) or another seminar for which the student completes a major research paper that could satisfy Option 2 of the Writing Requirement. The paper must be at least 30 pages in length and must be revised at least once in response to comments from the supervising professor.\*\* In general, this paper should be supervised by a Berkeley Law faculty member with expertise in environmental, land use, or natural resource law.

*\*\*Students enrolled in the Environmental Law Clinic may use a series of papers that total at least 30 pages to satisfy this requirement, so long as the papers could satisfy Option 2 of the writing requirement.*
