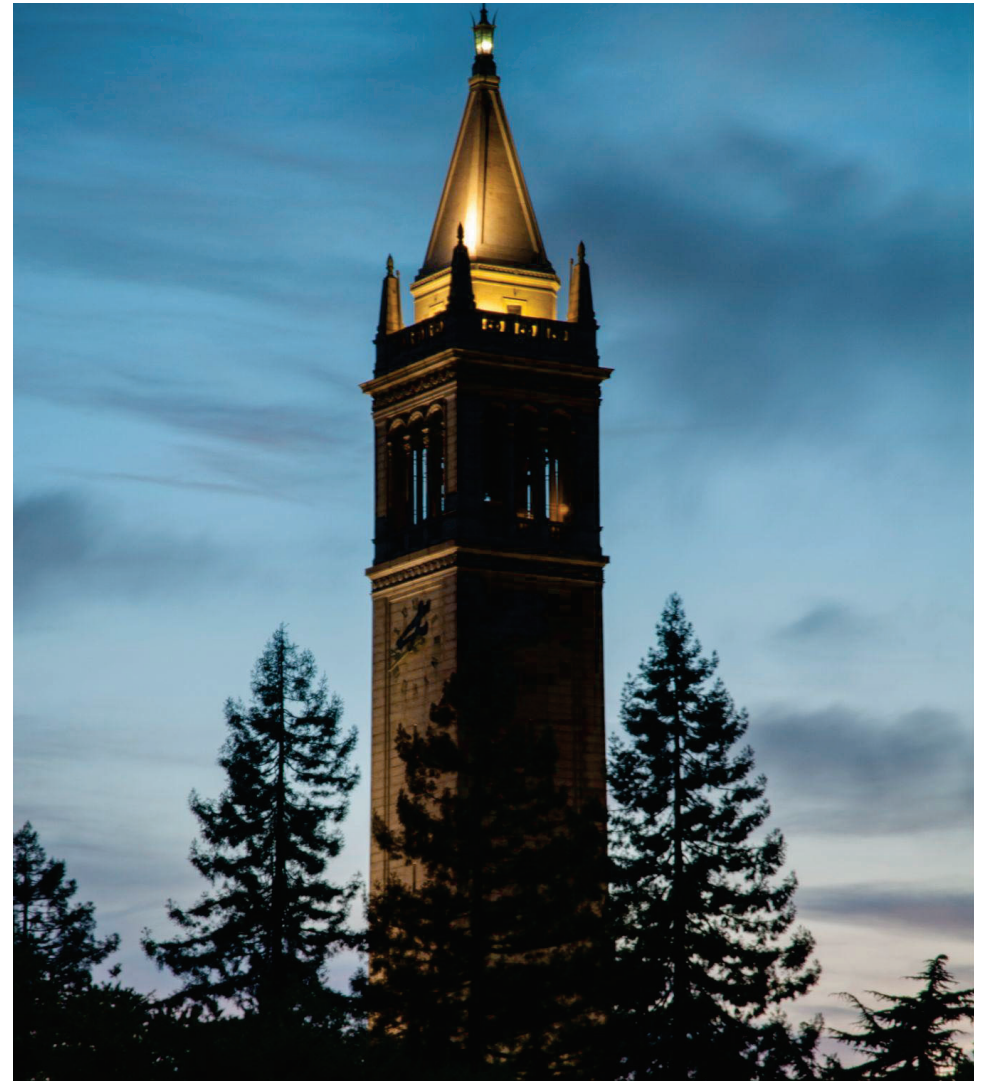

- ✓ 31 years of age or younger
- ✓ **Deadline to apply:** January 15, 2026 (see Nov 14 email announcement)
- ✓ Nominated by selection committee of Berkeley Law international law faculty, final decision by ICJ

Public Interest Fellowship (PIF) and Bridge Fellowship

Key Details:

PIF
<ul style="list-style-type: none">● One year fellowship.● Open to 3L JD students graduating May or December 2026.● \$49,500 fellowship + \$5,500 bar stipend.● Nonprofit or government host.● Great for building hands-on experience, mentorship, and professional development for full year.

Bridge
<ul style="list-style-type: none">● 4 month fellowship.● Open to 3L JD students graduating May or December 2026.● \$16,000 fellowship + \$5,500 bar stipend.● Nonprofit or government host.● May be good option where offices are guaranteed to hire new attorneys once they are licensed in December.

Use same application for both.

Applications will open in Spring on February 2, 2026.

Applications will close February 27, 2026.

Additional Notes (PIF/Bridge):

Priority to students applying widely for 3L PIPS jobs (no offers).

Secure eligible host organization, doing legal work supervised by attorney.

Register for first available bar exam.

Meet with PIPS counselor in CDO.

Continue to job search! Not guaranteed.
